Enclosed is a **RATE CHANGE** for the existing exception tariff, **Tristate 54, Effective August 14th, 2023, for Reads Moving Systems, Inc. (PA PUC Certificate #A-00097899) in Huntingdon Valley PA.**


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes 1 to 8 below - The transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE shown in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2 and 3.

Hourly Rates apply only from time of arrival of vehicles and men at the first point of origin (continue during all loading, transportation from the first point of origin to the final destination and unloading) until completion of unloading and dismissal of vehicles and men by the shipper at the final destination.

Traveling Charge covers traveling to the first point of origin and traveling from final destination, irrespective of actual time involved in such traveling.

- (c) Origin or destination is between 21 and 40 air miles of carrier's terminal: two (2) hours at the applicable rates.
- (d) When origin or destination is over 40 air miles of carrier's terminal, an additional one-half (1/2) hour charge at the applicable rates will apply for each additional 15 air miles.

Full-Value Replacement Protection with \$250.00 deductible is .70 per \$100.00 of the declared value

Full-Value Replacement Protection with \$500.00 deductible is \$.60 per \$100.00 of the declared value

The minimum coverage for Full-Value Replacement Protection is \$6.00 per pound or total value of \$10,000.00, whichever is greater.

▲ NOTE 7 - When requested by the shipper or required by the carrier to hold the shipment on the truck overnight in lieu of storage, the additional cost will be \$200.00 per vehicle per night.

▲ NOTE 8 - Reads Moving Systems, Inc. will access a booking commission up to a maximum 20% on the following shipment types

booked by a foreign agent:

Shipments transported forty (40) miles or less: The commission will be an agreed upon percentage of the total hourly transportation charges.

Shipments transported in excess of forty (40) miles: The commission will be an agreed upon percentage of the total linehaul transportation charge.

The additional booking commission will not be levied on any shipment sold by and booked by Reads Moving Systems, Inc.
