To Whom it May Concern:

On May 18, 2023, the Commission entered a Tentative Order, Docket No. M-2023-3040348, which advised Masha Mobile Moving and Storage LLC, t/a Zippy Shell of Greater Philadelphia that it was not in compliance with the insurance requirements of 66 Pa.C.S. § 512. The Tentative Order advised Masha Mobile Moving and Storage LLC, t/a Zippy Shell of Greater Philadelphia, that it must, within 30 days of publication of the Tentative Order, either have acceptable evidence of insurance filed with the Commission or cancel their authority or file comments to the Tentative Order. The Tentative Order advised Masha Mobile Moving and Storage LLC, t/a Zippy Shell of Greater Philadelphia, that, if it failed to respond, its certificate of public convenience would be cancelled. The Tentative Order was served on Masha Mobile Moving and Storage LLC, t/a Zippy Shell of Greater Philadelphia and published in the *Pennsylvania Bulletin*.

Masha Mobile Moving and Storage LLC, t/a Zippy Shell of Greater Philadelphia failed to respond to the May 18, 2023, Tentative Order and remains in non-compliance with the insurance requirements of the Public Utility Code at 66 Pa.C.S. § 512.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until a new application for authority is submitted. Additionally, all unpaid fines or assessments accrued while you had authority, are still due.

**YOU ARE ADVISED:** That the certificate(s) issued at Docket No. A-2017-2629670 be and is hereby *cancelled*, and all rights, powers, and privileges granted thereby shall forthwith cease and terminate.
