NOTICE OF OCCUPANCY OF THE EXECUTOR OFFICE

Re: The purpose, situation regarding this letter is to confirm, and acknowledge the appointment of Ex.: Higinio Mendoza, Jr. Estate, [and **Karen- Ann: Feitt**] to the Office of General Executor, Chief Administrator for the Trust, in all matters governing the Estate.

Greetings,

This "Executor Letter" is regarding the subject matter above. Before the Pennsylvania Public Utility Commission is a "NOTICE TO PLEAD", "ANSWER AND NEW MATTER OF PEOPLES NATURAL GAS COMPANY LLC", furthermore, the attorneys for Peoples Natural Gas Company LLC, is asking to that the "Third" Complaint of Karen Feitt be denied in its entirety and with prejudice the complaint be barred by res judicata and collateral estoppel.

Kindly notice, only a true person holding the position of "Executor Office" can function in the capacity for the estate that has authority. By whose (Third Complaint(s)) authority was it to administer the estate? Any unauthorized, delegated authority in writing, or documentation that was not authorized by the estate Executor Office is an assumption. In specific, the documents sent back to the Respondent regarding this case (C-2023-3040660 (Et al)), is "abandoned paperwork" **appearing as fraud**, not a

mistake. Therefore, the presumption of the presumed executorial or administrative authority is now rebutted, and the Office of Executor [Ex.: HIGINIO MENDOZA JR, estate] is the one with the authority for the case.

Documents sent to the estate by the Respondents' attorneys (Et al) were returned. The document(s) which do not distinguish or appeared as an assumption to the estate is returned as void for vagueness in an attempt to defraud the estate. More importantly documents to the estate in this manner is returned from the Executor Office, notifying anyone with an Executor Letter as to the violation of Trust Law, as it appears in this case.

In conclusion, the Pennsylvania Public Utility Commission in conjunction at the request of this Executor Letter shall direct the Respondent, and Peoples Natural Gas Company LLC, of the claim being valid. Therefore, to return since the time of the utilization of service, all interest, unearned income, property of the estate. It is hereby **ORDERED**: for the Bond or "You are hereby warranted this claim is hereby approved. The claim is hereby **Adjourned**." The recipients of the Executor Letter have 3 days to act on it after receipt.

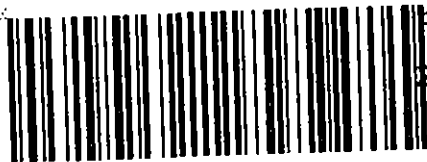

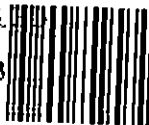
