
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Any Day, Any Hour: Two (2) hours at rates named in Columns 2 or 3 plus the applicable travel charge.

NOTE 2 - Hourly rates (Columns 2 and 3) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 3 - Carrier will assess and additional charge of \$15.00 per hour, or fraction thereof, for each flight above three flights. Each location of the move will be assessed separately.

NOTE 4 - When applicable during the course of the move, charges incurred by the carrier for tolls, parking fees or parking tickets will be the responsibility of the shipper and will be added to the total cost of the move.
