NOTICE OF OCCUPANCY OF THE EXECUTOR'S OFFICE

Re: The purpose, situation regarding this letter is to confirm, acknowledge the appointment of Higinio -: Mendoza, Jr., [and Karen- Ann: Feitt] to the Office of General Executor, Chief Administrator for the Trust, and in all matters governing the estate of HIGINIO MENDOZA, JR.

Greetings,

This "Executor Letter" is regarding the subject matter above. The administrative law judge, and the Pennsylvania Public Utility Commission made the Promulgation as a formal proclamation from administrative law that appears as an error. Only an individual holding the position of Executor Office can function in the capacity for the estate that has the authority. Therefore, by whose authority was it to administer the Estate, because only the one who occupies the Executor Office is the authority for (case closed) final approval.

The assertion made regarding the case is rebutted as a presumption of the presumed executorial or administrative authority. Higinio Mendoza, Jr., is the appointed Executor Office of the Estate, and is valid at the time of your receipt of this notice, **Nunc Pro Tunc**. Everything is

unauthorized, unless the Executor Office has delegated in writing such authority, and no such order was ever given from this Executor Office of the Estate at the time of the hearing (March 21, 2023) for the closing of the case.

Furthermore, the Pennsylvania Public Utility Commission, (ALJ) Mary D. Long, and Respondent Duquesne Light Company business is withholding benefits from the Estate. Therefore, the claim is valid for the return of the property of the estate. It is hereby **ORDERED**: for the Bond or "You are hereby warranted and this claim is hereby approved. The claim is hereby **Adjourned**." The recipient of the Executor Letter has 3 days to act on it after receipt.

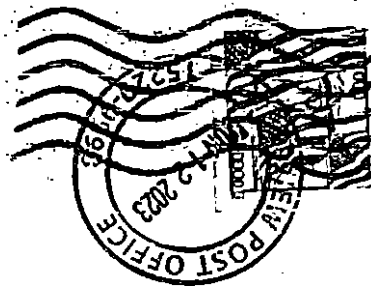
