Request for Information

Two filings for name changes were submitted to the Commission.

- a. One filing was submitted with a Utility Code of 700933, which corresponds to the Utility Code of Universal Truckloads LLC. This filing asked the Commission to change the name of Universal Truckload LLC to UACL Logistics LLC.

- b. Another filing was made with a Utility Code of A-00117019, which corresponds to the Docket No. of Economy Transport / Florida, LLC. This filing also asked the Commission to change the name of Universal Truckload LLC to UACL Logistics LLC.
 - i. Which carrier wishes to change their name to UACL Logistics LLC?

 - ii. Both carriers cannot change their name to UACL Logistics LLC.

 - iii. Property authority cannot be transferred. If, as it would appear, the two companies are part of the same corporate umbrella, and wish to operate under one name, then one carrier will need to discontinue their authority, and the other can change their name to UACL Logistics LLC.

A request for information will be sent to both carriers. Please answer both data requests (even if it is the same answers to both) so that we have an official answer for the record for both cases.
