Re: Natural Gas Supplier License of L5E, LLC d/b/a 5 Digital Energy

Dear Ms. Connolly:

On April 19, 2023, L5E, LLC (L5E) filed a request with the Commission to change the name on its license to provide natural gas services, as a broker/marketer, to L5E, LLC d/b/a 5 Digital Energy.

Currently, L5E is licensed as L5E, LLC as a broker/marketer to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC<sup>1</sup> – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc.<sup>2</sup>, and Valley Energy, within the Commonwealth of Pennsylvania.

L5E has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of L5E, LLC's name on its license for the provision of natural gas services as a broker/marketer.

**The Secretary's Bureau will issue a new license to L5E, LLC d/b/a 5 Digital Energy the right to begin to offer, render, furnish, or supply natural gas services as a broker/marketer to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC**


