NOTE 4 - When applicable during the course of the move, charges incurred by the carrier for tolls, parking fees or parking tickets will be the responsibility of the shipper and will be added to the total cost of the move.

NOTE 5 - When bulky items weighing 200 pounds or more are included in the shipment, an additional charge of \$150.00 per item will apply.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2 and 3 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 5 miles	1/2 hour
6 - 10 miles	1 hour
11 - 20 miles	1 1/2 hours
21 - 30 miles	2 hours
31 - 40 miles	2 1/2 hours

For mileage in excess of 40 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
