c. Our in-house driver training program shall be conducted in compliance with the Federal Motor Carrier Safety Administration Entry-Level Driver Training requirements.

d. Potential drivers will be required to provide their driving record information by obtaining such record from PennDot Driver & Vehicle Services.

e. Any alcohol or drug use during business hours is strictly prohibited. Drivers shall not come to work under the influence of alcohol or drugs. Periodic surprise alcohol and drug testing will be conducted and positive testing will result in immediate termination.

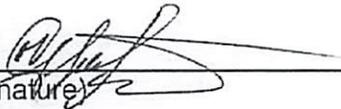
