**PETITION TO REINSTATE OPERATING AUTHORITY**

Petitioner New Beginning's Moving and Hauling, LLC hereby petitions to reinstate its authority to operate as a motor common carrier of household goods in-use between points in Pennsylvania, and states as follows:

1. Effective March 8, 2023, the Commission issued Petitioner a certificate of public convenience to operate as a motor common carrier of household goods in-use between points in Pennsylvania.
2. Petitioner's insurance carrier, Progressive, electronically filed a Form E on March 30, 2023, effective on April 28, 2023.
3. Unbeknownst to Petitioner, its name was changed in the Commission's records from "New Beginnings Moving and Hauling LLC" to "New Beginning's Moving and Hauling LLC" (adding the apostrophe in "Beginnings") and its business address was changed from its physical address to its post office box. Petitioner believes that these changes were migrated from its LLC filing in the Department of State's database. Regardless of the cause, this discrepancy resulted in the rejection of the March 30 Form E.
4. Progressive failed to timely contact Petitioner to inform Petitioner of the rejection of the March 30 Form E or timely resubmit the same. Petitioner has sought explanation from Progressive for this failure and received no response.

5. Petitioner is in the process of switching its policies to The Selzer Company from its current out-of-state insurance agency, and intends to rely on The Selzer Company's experience representing movers in Pennsylvania to ensure that similar errors will not occur in the future.
6. Petitioner thanks the Commission for its consideration of this Petition.

WHEREFORE, Petitioner New Beginning's Moving and Hauling, LLC respectfully requests that its operating authority to operate as a motor common carrier of household goods in-use be reinstated.


