- 1.) Tribe Moving, LLC intends to use a motor vehicle and/or an enclosed trailer to transport household goods in the Commonwealth of Pa.

A. Tribe Moving, LLC started as a company that would physically carry items from one room to another within a retirement community. We will continue to work in retirement communities, but we are now seeking PUC approval to broaden the scope of our business to include moves involving a motor vehicle that will be used for transporting items from one PA location to another. We would like to specialize in downsizing and continue to work with our current communities. We will complete small moves for private residences if requested or single item moves. Our vehicle is a 2022 Chevrolet 2500 Silverado with a 2020 -16-foot enclosed trailer. We have already applied for and received our PA DOT Number 4045361.


B. We do not intend on offering moves in excess of 40 miles. The retirement communities that we work in already are all within 15 miles of our shop.
