**Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective September 5<sup>th</sup>, 2023, for Ramsey's Moving Systems, LLC (PA PUC Certificate #A-00120024) in Media PA.**

The attached pages are 596<sup>th</sup> Revised Page 2, 87<sup>th</sup> Revised Page 2-C, 11<sup>th</sup> Revised Page 74-A, 1<sup>st</sup> Revised Page 74-A-1, and 2<sup>nd</sup> Revised Page 74-A-2

This filing is a request for a **CHANGE** in the service area to "between points in Pennsylvania" as this carrier was "grandfathered" statewide operating authority in May 2015, an **INCREASE** for local hourly rates and safe moving, an **INCREASE** for handling fees when a piano, large flat screen TV over 64 inches or copy machine are included in the shipment, an increase for the stair charge for safes or pianos, the **ADDITION** of travel charges for other counties within Pennsylvania, and an **INCREASE** in container and packing material charges.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2. Monday-Saturday (any hour): 3 hours at rates named in Columns 1, 3, and 4. For all safes and pianos, a 2 hours minimum charge applies to Column 5.

NOTE 2 - Item 325 in Tariff Freight Pa. P.U.C. No. 50 will not be offered.

NOTE 3 - Where storage-in-transit shipment is not unloaded at carrier's warehouse and shipment remains on carrier's vehicle, an overnight S.I.T. flat charge of \$250.00 per vehicle will be assessed. Waiting charge will be assessed by the carrier on the basis of a vehicle, driver and one helper at the applicable hourly rates shown above from 8:00AM following overnight S.I.T. flat charge until carrier's employees and equipment arrive at customer's location for unloading. Thereafter, carrier's hourly rates above will be assessed based on the equipment and location for unloading until completion of unloading and dismissal of equipment and labor by the shipper.

◆ NOTE 4 - When pianos, large TVs and copy machines are part of the shipment, the following flat rate charges will be assessed in addition to the hourly rates. Spinnet - \$100.00; High-Back Upright - \$225.00; Baby Grand - \$250.00; Grand Piano - \$600.00; Large Flat Screen TVs over 64" - \$250.00; and Copy Machine - \$225.00.

▲ In lieu of the applicable rates provided for in Tariffs Freight Pa. P.U.C. No. 50 and Freight Pa. P.U.C. No. 51 for the above carrier, the following accessorial charges shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less and distances in excess of forty (40) miles.

NOTE 5 - Moving items up steps when they will not fit in an elevator will be assessed \$35.00 per flight charge.

◆ NOTE 6 - (Column 5) Safes and Pianos will be assessed a one-time stair charge of \$85.00 for the first 1-5 steps and a charge of \$12.00 per step will be assessed over five (5) steps.

NOTE AA - (Applicable only to Delaware County)

A flat charge based on one hour at the applicable rates shown in Columns 2, 3 and 4 when distance from the original point of origin to the final destination is 10 miles or less.

A flat charge based on one and one-half hours at the applicable transportation rates shown in Columns 2, 3 and 4 when distance from the original point of origin to the final destination is more than 10 miles but not exceeding 20 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2, 3 and 4 when distance from the original point of origin to the final destination is more than 20 miles but not to exceed 40 miles.

NOTE BB - (Applicable only to Bucks, Chester, Lancaster, Montgomery and Philadelphia Counties)

- (1) Origin or destination are within 10 miles of carrier's terminal - 1 hour at applicable rates.
- (2) Origin or destination are between 11 and 20 miles of carrier's terminal - 1.5 hours at the applicable rates.
- (3) Origin or destination are between 21 and 30 miles of carrier's terminal - 2 hours at applicable rates.
- (4) Origin or destination are between 31 and 40 miles of carrier's terminal - 3 hours at applicable rates.

▲ NOTE CC - (Applicable to all other counties within Pennsylvania)

A flat charge of one-half (1/2) hour per each 15 miles will be assessed in addition to the hourly charges in Columns 2, 3 and 4 based on the combined mileage from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal.
