RE: Natural Gas Supplier License Application

Dear Mr. Jefremow:

On July 27, 2023, the Pennsylvania Public Utility Commission (Commission) received Natures Current LLC.'s application for a Natural Gas Supplier (NGS) license.

The applicant stated throughout its NGS Application Package that the name of the applicant is "Natures Current, LLC.". According to the applicant's PA Department of State registered name, the name must be written as "Natures Current LLC." (notice the punctuation difference). All instances of this error must be corrected throughout the NGS Application Package.

Sections 1.a, 1.e, 5.a, 5.c, 7.a, 7.b, 7.f, and 8.e of the application were incomplete or not properly completed (ex. 5.a and 5.c stated not applicable). In order for the Commission to accept the application for review, these deficiencies must be corrected. Failure to respond timely will result in the application being deemed rejected<sup>1</sup> and the docket will be closed.

Please use the Commission's e-filing system or an overnight delivery service to submit the requested information to the Secretary of the Commission **within 20 days** from the date of this letter. Please submit revised application pages for each section. The Commission accepts all public documents through our e-filing system and strongly recommends companies open an e-filing account through the Commission's website at <https://efiling.puc.pa.gov>. The use of the e-filing system will ensure that submissions by the company are received timely and receipt can be verified.


