Based upon your representations, Philadelphia Gas Works has determined that, at this time, Energy Zebra LLC does not need to post a bond or other form of security to operate in its service territory. If the services provided by Energy Zebra LLC should change, Philadelphia Gas Works reserves the right to require security from Energy Zebra LLC as it deems appropriate.
