**JOINT REPORT OF THE PARTIES**

AND NOW come the parties to the above captioned action, and, in response to the Commission’s Interim Order Setting Deadline for the Filing of Joint Stipulation of Facts (the “Interim Order”), submit the following joint report of the parties.

On July 25, 2023, Office Partners submitted a Motion for Directed Verdict or Alternatively to Supplement Motion for Summary Judgment and Response to PWSA’s Motion for Summary Judgment and to Extend Time for Stipulations and Status Report (the “Office Partners Motion”). In light of the filing of the Office Partners Motion, which occurred after the entry of the Interim Order, and following a meet-and-confer conference, the parties have agreed as follows: that the submission of Joint and/or Independent Status Reports, for use in the Commission’s consideration of the parties respective Motions for Summary Judgment, be stayed until the Commission enters a modified case management order, providing new deadlines for any additional submissions. The parties respectfully request that relief from the Commission with respect to the submission of stipulations.

The PWSA intends to file a Brief and Answer in response to the Office Partners Motion, opposing the substantive relief sought in the Motion, to the extent the Motion seeks the entry of a Directed Verdict.
