MOTION

- 1- In conjunction with the Motion dated August 1, 2023, I Mr. M. Hillman Motion the Court, requesting that the Court Decisions, Judgments, Orders or Motions from the Respondents (all requiring a timely response) be sent by U.S. Certified Mail.

- 2- Just recently, I filed a Motion for a possible extension of time, to respond to an Order that I have never seen, as of yet. 
