Dear Secretary Chiavetta:

The purpose of this letter is to advise the Pennsylvania Public Utility Commission ("Commission") that Vistra Corp's ("Vistra") subsidiary Everyday Energy, LLC d/b/a Energy Rewards ("Energy Rewards") is assigning all its remaining Commonwealth of Pennsylvania customers to another Vistra subsidiary, Energy Services Providers, LLC d/b/a Pennsylvania Gas & Electric ("PAG&E"). Energy Rewards will assign to PAG&E approximately 793 contracts for the provision of electric generation services to Pennsylvania commercial and non-commercial customers. Energy Rewards will have no remaining Pennsylvania customers after the customer transfer but will retain its Electric Generation Supplier license. Everyday Energy, LLC d/b/a Energy Rewards license docket number is A-2012-2314724 and Energy Services Providers, LLC license docket number is A-2010-2212421.

A 30-day notice is being sent to the impacted customers to inform them of the contract transfer. A copy of the template notice is provided in confidential Appendix A. The notice includes the following information:

- The transfer of service from Energy Rewards to PAG&E will be initiated after the expiration of the 30-day notice period and that the effective date of the transfer is expected to occur as of September 11, 2023.
- An explanation of the reason for the contract assignment
