Dear Secretary Chiavetta:

Pursuant to the instructions of the Secretary's Bureau, Metropolitan Edison Company ("Met-Ed"), Pennsylvania Electric Company ("Penelec"), Pennsylvania Power Company ("Penn Power"), West Penn Power Company ("West Penn"), Keystone Appalachian Transmission Company ("KATCo"), Mid-Atlantic Interstate Transmission, LLC ("MAIT"), and FirstEnergy Pennsylvania Electric Company ("FE PA"), hereinafter, collectively, the "Joint Applicants," hereby submit this letter evidencing that copies of the Joint Applicants' Pre-Served Testimony and Exhibits, which were admitted into the record during the evidentiary hearing held on August 10, 2023, were provided to the court reporter.
