RE: Natural Gas Supplier License Application

Dear Ms. Castillo:

On August 11, 2023, the Pennsylvania Public Utility Commission (Commission) received CGE RENEWABLES LLC's application for a Natural Gas Supplier (NGS) license.

The applicant stated throughout its NGS Application Package that the name of the applicant is "CGE Renewables, LLC". According to the applicant's PA Department of State registered name, the name must be written as "CGE RENEWABLES LLC" (notice the capitalization and punctuation differences). All instances of this error must be corrected throughout the NGS Application Package including the Affidavits.

Sections 1.a, 1.c, 7.a, 8.e, and 12 of the application were incomplete or not properly completed (ex. 8.e is required for both Suppliers and Brokers, the Applicant's combined EGS/NGS notarized publications do not list all of the Applicant's proposed service areas). In order for the Commission to accept the application for review, these deficiencies must be corrected. Failure to respond timely will result in the application being deemed rejected<sup>1</sup> and the docket will be closed.

Please use the Commission's efiling system or an overnight delivery service to submit the requested information to the Secretary of the Commission **within 20 days** from the date of this letter. Please submit revised application pages for each section. The Commission accepts all public documents through our efiling system and strongly recommends companies open an efiling account through the Commission's website at <https://efiling.puc.pa.gov>. Use of the efiling system will ensure that submissions by the company are received timely and receipt can be verified.


