Dear Natures Current LLC:

PECO is aware that Natures Current LLC has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

In making such an application Natures Current LLC could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. Natures Current LLC has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers will not take title to any delivered natural gas; nor will accept any customer payments or deposits.
