CleanChoice Energy, Inc. ("CleanChoice") hereby submits an update to its corporate structure to the Pennsylvania Public Utility Commission.

On June 27, 2023, CleanChoice Energy Holdings Inc. - the ultimate parent of CleanChoice Energy, Inc. ("CleanChoice") - merged with certain affiliates of investment funds managed by True Green Capital Management LLC ("True Green Capital"). As a result of the transactions contemplated by the Agreement and Plan of Merger, CleanChoice became a wholly owned subsidiary of CCE Group Holdings, Inc., a newly formed Delaware corporation and an affiliate of investment funds managed by True Green Capital. CleanChoice expects no immediate material changes in the operation of its business and will continue to maintain all appropriate licenses and qualifications. For your reference, please find a diagram showing the new corporate structure attached.

CleanChoice respectfully requests confidentiality for the diagram of the new corporate structure. This material change contains sensitive operational information for CleanChoice, and such information, if it were to become publicly available, could harm the competitive and commercial operations of CleanChoice by providing competitors with access to CleanChoice's recent operating information providing direct insight into market position, size, and other closely held proprietary business information. Accordingly, this submission includes a confidential version and a public redacted version.




