Dear Bakey Energy Consulting:

PECO is aware that Bakey Energy Consulting has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

In making such an application Bakey Energy Consulting could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. Bakey Energy Consulting has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers will not take title to any delivered natural gas; nor will accept any customer payments or deposits.

Therefore, PECO has determined at this time that Bakey Energy Consulting does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by Bakey Energy Consulting or the creditworthiness requirement for PECO's exposure to Bakey Energy Consulting changes in the future, PECO reserves the right to require Bakey Energy Consulting to provide a bond or other financial security instrument.
