

- 1.) Upon completing our review of the submitted application for Experimental Service, it would appear that the service you wish to provide would be covered under Paratransit Authority. As such, please submit a completed application for Paratransit authority (https://www.puc.pa.gov/documents/utility-files/432/App_MC_Persons_Paratransit_Service120621.pdf), as well as a statement that you wish to amend your application to Paratransit.
 - In your application it was also noted that you described the service area as “the Greater Pittsburgh area.” Unfortunately, this is not a recognized area with clear and defined boundaries that can be easily identified on a map. As such, please clarify where you wish to originate and terminate service and do so in manner with clear and defined boundaries that can be easily identified on a map. (ex. between points in Allegheny County, etc...)
 - It was also noted that you mentioned grocery shopping. Please be aware that if you intend to have your drivers transport groceries or other “property,” outside of transporting the individuals, then you will also need to apply for Property authority. https://www.puc.pa.gov/documents/utility-files/307/App_MC_Property100521.pdf
