On behalf of The O.E. Group Inc, we are enclosing revised documents in response to the deficiency letter received in the above referenced docket, on August 28, 2023.

The business entity name on this document has been revised to reflect the exact punctuation as is shown on the PA Department of State registration.

We are also enclosing revised Application and Operations affidavits which should replace Appendix A and Appendix B in our original filed Application. The names on these affidavits were corrected and modified to reflect the exact punctuation shown on the PA Department of State registration.

Additionally, to the extent that the Application makes any reference to THE O.E. GROUP INC. that is not exactly as shown on the PA Department of State registration, we affirm that it is a reference to the same company. Alternative representations may be "The OE Group," "The O.E. Group," "The O.E. Group Inc." "the O.E. Group" or other similar derivatives. THE O.E. GROUP INC does not have any affiliate or subsidiary organizations operating under different versions of the actual filed name. All such references in the Application or supporting documentation are references to the same company.
