Request for Information

- 1.) Question #10 of the application asks you to describe the service being proposed by the application. You said, “The service area that will be serviced is within Pennsylvania City limits. This vehicle will be used to transport individuals to and from all Pennsylvania State Penitentiaries. It will also be used to transport individuals to medical appointments as well as transport them for shopping errands and other places as needed.”
 - Please clarify what do you mean by “within Pennsylvania City limits?” The service area needs to have clear and defined boundaries that can be easily identified on a map.
 - Please identify the area(s) of termination for those receiving transportation to not to Pennsylvania State Correctional institutions.

- 2.) Please file a new, dated, Statement of Financial Position (Balance Sheet) that does not include personal assets or liabilities. The only information that should be listed on the Balance Sheet should be the financials of the LLC.

- 3.) You mention that Richard Blake Cottle is no longer with the LLC, but he is still listed on the application as a member. Please verify that Mr. Cottle is no longer a member of the LLC.
