On August 3, 2023, the Commission received the above referenced application. On August 4, 2023, the Commission sent notice to the PA Bulletin to appear in the August 25, 2023 issue, with a protest period ending September 5, 2023.

Pursuant to 52 Pa. Code, §1.57 and §1.58, you must serve copies of the Application upon the following parties, then file proof of such service with this Commission,

A water or wastewater utility, municipal corporation or authority which provides water or wastewater collection, treatment and disposal service to the public and whose service area abuts the service area proposed in the application;


The Department of Environmental Protection's appropriate regional office.

You are also directed upon receipt of this letter to publish the enclosed notice once a week for two consecutive weeks in a newspaper having a general circulation in the area affected by the Application, and file proof of all publications with the Commission on or before Tuesday, October 10, 2023.

The notice will not be published in the Pennsylvania Bulletin again.
