**MOTION OF PECO ENERGY COMPANY FOR CONTINUANCE OF  
INITIAL TELEPHONIC HEARING DATE**

---

PECO Energy Company (“PECO” or the “Company”), pursuant to 52 Pa. Code §1.15(b), hereby respectfully requests a continuance of the initial telephonic hearing date scheduled in this matter and, in support, states the following:

1. An initial telephonic hearing in this matter was originally scheduled for Tuesday, August 22, 2023 at 10:00 A.M.
2. On July 26, 2023, PECO requested a continuance of the August 22, 2023 hearing date due to ongoing settlement discussions between PECO and the Commission’s Bureau of Investigation and Enforcement (“I&E”). I&E also consented to PECO’s request for continuance. Your Honor granted PECO’s request, and the new initial telephonic hearing date is currently scheduled for Tuesday, October 10, 2023.
3. Since that time, PECO and I&E (collectively, the “Parties”) have actively engaged in fruitful settlement negotiations.
4. The hearing notice in this matter states, “[y]ou may request a continuance of the hearing if you have a good reason. All continuances will be granted only for good cause.”


5. PECO avers that “good cause” exists to continue the scheduled hearing to a later date to allow the Parties additional time to contemplate and possibly complete a settlement.

6. PECO is now requesting a sixty (60) day continuance of the October 10, 2023 hearing date to continue these settlement negotiations and work toward the filing of a Joint Petition for Settlement.

7. PECO is authorized to represent that I&E supports this request for a continuance of the October 10, 2023 hearing date.

8. The Parties respectfully request another sixty (60) day continuance, at which time the Parties will provide Your Honor an update regarding the status of settlement discussions or request another hearing date.


