Dear Secretary Chiavetta:

Pursuant to the annual reporting requirement of Section 59.111 of the Commission's Regulations, National Fuel Gas Distribution Corporation ("National Fuel") is submitting its Unaccounted-for-Gas (UFG) Report for the 12 months ending August 31, 2023.

For the following reasons, National Fuel reports only for its distribution system:

- All local production feeds directly into National Fuel's distribution system; there is no local production/gathering system.
- Although National Fuel contracts for storage service from upstream interstate pipelines, it has no storage system itself. Pipeline storage activity (injections, withdrawal and fuel/loss retention) has no impact upon UFG within National Fuel's distribution system.
- While National Fuel does have a relatively small amount of transmission capacity, there is no measurement between the transmission facilities and the distribution system. As a result, any transmission UFG will be reported as a part of the distribution system UFG.
