**Notice of Change in Ownership**

Dear Secretary Chiavetta:

This letter serves as notice to the Pennsylvania Public Utility Commission of change in ownership of Vanguard Energy Services, LLC ("Vanguard") that occurred on August 31, 2023.

On August 31, 2023, 100% of the ownership interest of Vanguard, was acquired by NextEra Energy Services Acquisitions, LLC. The transaction resulted in: (1) a change in control of Vanguard, (2) a change in officers, and (3) a change in regulatory contact. Vanguard will continue its operations in Pennsylvania, with business operations, services, customer population, and address remaining unchanged.

1. As a result of this transaction, Vanguard, is now owned by NextEra Energy Services Acquisitions, LLC, which is an indirect wholly owned subsidiary of NextEra Energy, Inc. ("NextEra Energy"). A leading clean energy company headquartered in Juno Beach, Florida, NextEra Energy owns Florida Power & Light Company, which serves more than 5 million customer accounts in Florida and is the largest rate-regulated electric utility in the United States as measured by retail electricity produced and sold. NextEra Energy also owns a competitive energy business, NextEra Energy Resources, LLC ("NEER"), which, together with its affiliated entities, is the world's largest generator of renewable energy from the wind and sun and a world leader in battery storage. A Fortune 200 company and included in the S&P 100 index, NextEra Energy has been recognized often by third parties for its efforts in sustainability, corporate responsibility, ethics and compliance, and diversity. Specifically, this letter includes the following updates: corporate ownership structure, principal officers responsible for Iowa operations, and regulatory contact.
