**ORDER**

**BY THE COMMISSION:**

On August 31, 2023, Conneaut Lake Park Water Corporation, Inc. (Conneaut), Utility Code 2125112, filed Tariff Supplement No. 1 to Water – Pa. P.U.C. No. 1 (Supplement No. 1) with the Pennsylvania Public Utility Commission (Commission) to become effective October 31, 2023. Supplement No. 1 would increase Conneaut’s total annual operating revenues for water service by approximately \$257,797, or 970.8%.

On September 18, 2023, the Office of Consumer Advocate filed a formal complaint at Docket No. C-2023-3043091. On September 20, 2023, the Office of Small Business Advocate filed a formal complaint at Docket No. C-2023-3043163. Pursuant to Section 1308(d) of the Pennsylvania Public Utility Code, 66 Pa.C.S. § 1308(d), the filing will be suspended by operation of law until May 31, 2024, unless permitted by Commission Order to become effective at an earlier date.

Investigation and analysis of this proposed tariff supplement and the supporting data indicates that the proposed changes in rates, rules, and regulations may be unlawful,

unjust, unreasonable, and contrary to public interest. It also appears that consideration should be given to the reasonableness of Conneaut's existing rates, rules, and regulations; **THEREFORE,**

**IT IS ORDERED:**

1. That an investigation on Commission motion be, and hereby is, instituted to determine the lawfulness, justness, and reasonableness of the rates, rules, and regulations contained in Conneaut Lake Park Water Corporation, Inc.'s proposed Tariff Supplement No. 1 to Water – Pa. P.U.C. No. 1.

2. That Conneaut Lake Park Water Corporation, Inc.'s proposed Tariff Supplement No. 1 to Water – Pa. P.U.C. No. 1 is suspended by operation of law until May 31, 2024, unless otherwise directed by Order of the Commission.

3. That within ten (10) days following the entry date of this Order, pursuant to 52 Pa. Code § 53.71, Conneaut Lake Park Water Corporation, Inc. shall e-file (or file) a tariff supplement, which shall bear no effective date, with the Commission and post the tariff supplement at the offices of Conneaut Lake Park Water Corporation, Inc. announcing that the aforementioned tariff supplement is suspended until May 31, 2024. A sample copy of a suspension supplement is provided in Attachment A of this Order.

4. That the investigation instituted in Ordering Paragraph No. 1 of this Order shall include consideration of the lawfulness, justness, and reasonableness of the existing rates, rules, and regulations of Conneaut Lake Park Water Corporation, Inc.

5. That this case be assigned to the Office of Administrative Law Judge for Alternative Dispute Resolution, if possible, and for the prompt scheduling of such hearings as may be necessary culminating in the issuance of a recommended decision.

6. That a copy of this Order shall be served upon Conneaut Lake Park Water Corporation, Inc., the Commission's Bureau of Investigation and Enforcement, the Office of Consumer Advocate, the Office of Small Business Advocate, and any persons who have filed formal complaints against the proposed tariff supplement.
