Dear Secretary Chiavetta:

Conneaut Lake Park Water Corporation ("CLPWC") has been served with a number of formal complaints in the above-captioned matter and anticipates that additional formal complaints will be filed. On October 19, 2023 the Pennsylvania Public Utility Commission (the "Commission") entered an Order, suspending the tariff and initiating an investigation of CLPWC's rate increase request at the above-captioned Docket No. Consistent with Commission practice, CLPWC anticipates that all complaints filed with respect to its proposed rate increase will be consolidated in that proceeding. Accordingly, with respect to the Complaints that have been filed, and any complaints hereafter filed, CLPWC, in lieu of filing answers thereto, will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.




