*To transport, as a common carrier, by motor vehicle, persons in limousine service, from points in Franklin County, Cumberland County, Fulton County east of US Route 522 (including all of the Borough of McConnellsburg), Huntingdon County east of US Route 522 and south of PA Route 641 (including all of the Borough of Shade Gap), and Adams County west of US Route 15 (including all of the Borough of Gettysburg) to points in Pennsylvania and return; excluding the areas under the jurisdiction of the Philadelphia Parking Authority.*

## RULES & REGULATIONS

1. Advance reservations are required and must be made twenty-four (24) hours prior to service being rendered.
2. Full payment is required prior to service.
3. Hourly rates commence at the time the vehicle arrives at the first pick up point of the client and shall conclude at the last drop-off point of the client.
4. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
5. Trips on the following Holidays are subject to additional fees as stated in the fee schedule:
  - New Year's Eve and New Year's Day
  - Easter Day
  - Memorial Day
  - Independence Day
  - Labor Day
  - Thanksgiving Day and Black Friday (Day after Thanksgiving)
  - Christmas Eve and Christmas Day
6. Additional charges apply if pickup occurs prior to 6:00AM or the drop off occurs after 10:00PM.
7. An automatic gratuity of 20% shall be added to all charges.

## SCHEDULE OF RATES

Hourly Rates: Minimum charged will be for one (1) hour, or any fraction thereof.

Additional time will be charged in thirty (30) minute / half hour increments, or any fraction thereof, at the following rates:

### Luxury SUV:

Standard Hour Rates: 6:00 AM to 10:00 PM

One hour \$120.00

Additional 30 Minutes, or any fraction thereof: \$60.00

Evening Hour Rates: 10:00 PM to 6:00 AM

Standard rates apply with an additional \$60.00 surcharge.

Weekend Hour Rates: Saturday 12:01 AM to Monday 7:59 AM

Standard rates apply with an additional \$60.00 surcharge.

Holiday Rates: 12:01 AM TO 11:59 PM

Standard rates apply with an additional \$120.00 surcharge.
