### **Safe Transportation Group LLC, t/a Prime on Time and Corporate Express Cab**

To Whom It May Concern:

On **September 5, 2023**, the Bureau of Investigation and Enforcement instituted a Complaint against Safe Transportation Group LLC, t/a Prime on Time and Corporate Express Cab, Respondent, for failure to file an application with this Commission prior to abandoning or discontinuing call or demand service, a violation of 52 Pa. Code §3.3819(a) and 66 Pa. C.S. §1102(a)(2).

In accordance with 52 Pa. Code §5.61, the Bureau of Investigation and Enforcement notified the Respondent that, an Answer to the Complaint must be filed within twenty (20) days of the date of service. The Notice further specified that, if Respondent failed to answer the Complaint within twenty (20) days, the Bureau of Investigation and Enforcement would request that the Commission cancel Respondent's Certificate of Public Convenience.

The Complaint was served on Respondent Safe Transportation Group LLC, t/a Prime on Time and Corporate Express Cab, *via* certified mail on **September 8, 2023**. To date, more than twenty (20) days later, Respondent has failed to file an Answer to the Complaint or file an application to abandon or discontinue call or demand service with this Commission.

Therefore, the allegations in the Complaint are deemed to be admitted. The Complaint is hereby sustained and the **Certificate of Public Convenience**, issued to Respondent, Safe Transportation Group LLC, t/a Prime on Time and Corporate Express Cab, at **A-2017-2612170** is **hereby CANCELLED**.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§1.1 et seq. and the regulations of the Commission, 52 Pa. Code §§1.1 et seq. In view of the **cancellation of respondent's Certificate of Public Convenience**, it is specifically prohibited from rendering call or demand service as a common carrier by motor vehicle in intrastate commerce in the Commonwealth of Pennsylvania.

### APPEAL RIGHTS

If you disagree with this determination, you may send a Petition for Reconsideration from Staff Action (Petition) to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. Such a Petition is a written statement asking the Commission to change its determination.

**ALL Parties to proceedings pending before the Commission are advised open and use an e-filing account through the Commission's website. If a filing contains confidential or proprietary material, the filing is required to be submitted by overnight delivery.**

The Petition must be filed with the Commission within twenty (20) days of the date of this letter. If no timely request for reconsideration is made, this action will be deemed to be the final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request, (2) the case docket number(s) (they are provided for you at the top right hand corner of this letter), (3) the name of the person on whose behalf the petition is made, (4) copies of relevant documentation, and (5) a verification with original signature. *See* 52 Pa. Code §§1.31 and 5.44. Follows is a sample Verification:


