The Office of Consumer Advocate respectfully submits this Letter of Support to be included in the record of this matter.

On October 26, 2023, the Bureau of Investigation & Enforcement of the Public Utility Commission filed an Exception to the Initial Decision on Remand of Administrative Law Judge Katrina L. Dunderdale (ALJ). Like I&E, the OCA supports the ALJ's well-reasoned recommendation to approve the proposed, unanimous settlement. The OCA also supports I&E's limited Exception, in which it requests that the Ordering Paragraphs be clarified to match the 120-day timeframe for completion and filing of the audit that was agreed to by all parties to the proposed settlement.
