  - b. Your driver training program.
    - i. What type of training will you conduct for the drivers that you employ?
  - c. Your system for conducting driver license checks?
    - i. How will you be conducting your checks of driver licenses for drivers?
    - ii. How often will these checks be performed?
    - iii. How will you maintain records of such checks?
  - d. Your policies regarding alcohol and drug use by your drivers?
    - i. Other than passing an initial drug test to be hired, what other policies are in place for drug and alcohol use by your drivers.
