- Transportation of people whose personal convictions prevent them from owning or operating motor vehicles.
- Transportation of people to correctional facilities for visitation.
- Transportation of people in wheelchair and stretcher vans.

***Important Note: Paratransit carriers may not render service to or from airports.**

2. Upon approval of the application, you will be notified that prior to providing service in Pennsylvania you must submit evidence of insurance to the Public Utility Commission. **Your permanent evidence of insurance will be a Form E for bodily injury and property damage insurance.** This form is mailed to the Commission directly from the home office of your insurance carrier. The name and address on your Form E must **exactly** match the name and address you have provided on your application. Your insurance company must subscribe to the NIC Insurance Filing website at www.nicinsurancefilings.com. You will request the insurance company (not the agent) to file the required insurance forms electronically through NIC. Mailed insurance forms are no longer acceptable. The minimum limits of insurance are as follows:

We are planning to hire two drivers, a number we believe will adequately address our projected service demand. Each driver should be at least 21 years old and have held a valid U.S. driver's license for a minimum of three years. We will conduct a thorough background check on every candidate, examining their criminal history, driving records, and other pertinent databases. We will maintain records of criminal background checks by using standardized forms for collecting and documenting information related to background checks and ensure that these forms comply with the relevant legal requirements. Any candidate with a felony conviction in the past 7 years, especially those related to violent acts, sexual misconduct, theft, or property damage, will be excluded. We will not consider candidates with DUI or drug-related offenses in the previous 5 years or major driving infractions, like reckless driving, within the last 3 years. We may also require a medical fitness card to ensure the driver's physical capability and safety on the road. Our drivers will receive training on safe driving, customer relations, and PUC regulations. We have a strict policy against drug or alcohol consumption during work hours. Lastly, we will diligently verify essential documents such as their license, residency proof, insurance papers, and vehicle registration. Regular evaluations will be conducted to monitor drivers for any infractions or concerns, and we will act promptly to address any issues.
