
Dear Secretary Chiavetta:

On behalf of Raiser-PA LLC ("Raiser"), enclosed is a check for one-hundred and fifty dollars (\$150.00). This is the fine amounts requested by the Bureau of Investigation and Enforcement to terminate further proceedings in connection with the above-captioned Complaint ("Complaint"). The Complaint alleges that Raiser is subject to the Pennsylvania Public Utility Commission's jurisdiction pursuant to a license issued to Raiser at Docket No. A-2016-2580821 on January 26, 2017, authorizing the transportation of persons for compensation in Transportation Network Company ("TNC") service. In addition, the Complaint alleges that Raiser is in violation of 66 Pa. C.S. §2605(b)(8), governing the marking of vehicles and 66 Pa. C.S. §2626(a), governing that a vehicle cannot operate with passengers in greater numbers than the vehicle seat belt count. The Complaint's allegation regarding 66 Pa.C.S. §2626(a) appears to be a typographical error and the reference was intended to be to 66 Pa.C.S. § 2606(a), which references transporting a greater number of individuals, including the driver, than the number of seat belts factory installed in the vehicle.

Raiser does not contest payment of the requested fine and is forwarding this amount in order to resolve and close this Complaint.

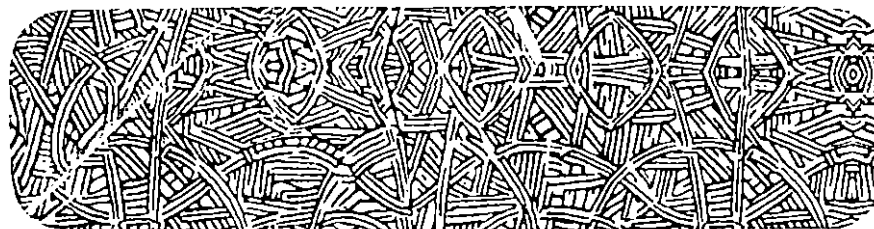
