Each city, borough, town, township, county and related planning office, which is included, in whole or in part, in the proposed service area;



You are directed upon receipt of this letter to publish the enclosed notice once a week for two consecutive weeks in a newspaper having a general circulation in the area involved and file proof of publication with the Commission on or before **December 11, 2023**.

Pursuant to 52 Pa. Code §5.14, the Commission will proceed with publishing the attached notice in the Pennsylvania Bulletin. This notice will appear in the **November 25, 2023**, issue.


