In accordance with a request from the Commission's Bureau of Consumer Services, PECO Energy Company ("PECO" or the Company) is hereby providing an informational letter listing its CAP Maximum Credit amounts. Per the Commission-approved Universal Service and Energy Conservation Plan ("USECP"), if PECO is granted an electric base rate increase, Annual CAP Maximum Credit amounts for Electric Heating and Electric Non-Heating customers are increased by a percentage equal to the system-wide residential distribution rate increase. *See* PECO USECP, pg. 5, footnotes 4 and 5.

To that end, below please find the Annual CAP Maximum Credits that have been in place since the effective date of PECO's most recent electric base rate case, January 1, 2022:

### **Annual Maximum Credit Amounts**

FPL	Electric Non- Heating (Rate R) <sup>4</sup>	Electric Heating (Rate RH) <sup>5</sup>	Gas
0-50%	\$2,693	\$3,835	No maximum
51-100%	\$1,897	\$2,547	No maximum
101-150%	\$1,719	\$2,275	No maximum
