Dear Secretary Chiavetta,

CleanSky Energy received authority to reduce its security with the Pennsylvania Public Utility Commission from 10% to 5% of CleanSky Energy's most recent twelve months of revenue, pursuant to the Secretarial Letter dated December 2, 2022. CleanSky Energy hereby submits this Annual Compliance filing to renew its security at the reduced level of 5% based on its most recent twelve months of revenue in accordance with the Commission Order deemed final on October 16, 2018, at Docket No. P-2017-2608078. The expiration date of our current financial security is February 8, 2024.

CleanSky Energy provides the following information and documentation in support of its Annual Compliance Filing:

- 1. A spreadsheet of CleanSky Energy's gross receipts in Pennsylvania for the most recent 4 quarters (October 2022 through September 2023) and a 5% gross receipt calculation attached hereto as **Exhibit A (CONFIDENTIAL)**;
- 2. A copy of CleanSky Energy's confirmation from the Pennsylvania Department of Revenue that it has prepaid gross receipts, attached hereto as **Exhibit B (CONFIDENTIAL)**;
- 3. A letter from the AEPS Administrator (AEPS) confirming CleanSky Energy's compliance with AEPS requirements attached hereto as **Exhibit C**;
- 4. A Tax Status Letter from the Pennsylvania Department of Revenue to evidence that CleanSky Energy is current with its tax liabilities to the Commonwealth, attached hereto as **Exhibit D**; AND
- 5. A Certificate of Service and proof of annual fee invoice payments, attached hereto as Exhibit E.
- 6. An updated surety bond reflecting a 5% calculation of the most recent 4 quarters of gross receipts, attached hereto as **EXHIBIT F.**
