On November 6, 2023, the Pennsylvania Public Utility Commission (Commission) received Priority Power Management LLC dba PPM Atlas's (Priority Power) application for a Natural Gas Supplier (NGS) license. In order for us to complete our analysis of Priority Power's NGS Application, the Commission's Energy Industry Group requires answers to the attached questions.

Please provide an explanation for this statement and clarify the relationship between the applicant to these two entities.
2. Reference Application, Section 3.a and 3.b, Affiliates and Predecessors – The Commission’s records indicate that Priority Power is currently licensed as an electric generation supplier (EGS) at Docket No. A-2011-2245433, if the applicant is affiliated with this EGS, please submit updated pages 7 and 8, with the affiliate’s name and Docket No. indicated. Alternatively, please indicate that the applicant and this EGS licensee are not affiliated.
3. Reference Application, Section 7.a, Financial Fitness – Applicant failed to provide natural gas distribution company bonding letters for each utility in whose service territory it wishes to operate. Please provide the missing documentation.
4. Reference Application, Section 7.b, Financial Fitness – Applicant provided unaudited financial statements to demonstrate financial fitness. Please provide financial fitness documentation that may include two recent consecutive years of income tax filings, and three recent consecutive months of bank statements, etc.
