COMPLAINT

The Pennsylvania Public Utility Commission (Commission or PUC) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That QUENTIN KURT WEST, Respondent, maintains its principal place of business at 7 E. Marshall Ave, Pittsburgh, Pennsylvania, 15214.

2. A certificate of public convenience issued by this Commission is required to transport passengers for compensation, in call or demand service, within the Commonwealth of Pennsylvania. Based on a review of the records maintained by the Commission, Quentin Kurt West does not hold a certificate of public convenience.


3. On July 6, 2023, Respondent was issued a warning letter for the transportation of passengers for compensation without authority/certificate. Respondent was also advised that by attaching a yellow roof light with the word "AVAILABLE" on his vehicle it was a violation of 75 PA C.S. §4307 and directed to cease and desist from further violations and the penalties that could be assessed due to those activities.

4. On October 10, 2023, the Pittsburgh Regional office received a complaint with a photo of Respondent's same vehicle displaying the same dome light as described in the July 6, 2023, matter/warning. A review of Commission records indicates the Respondent has not applied for authority/certificate from the Commission. Since Respondent continues to operate as a call or demand service (Taxi), without obtaining the required certificate / authority from the Commission, Respondent is in violation of 66 Pa C.S. & 1101 and penalized the \$1,000.00. Subsequent violations will result in Criminal charges being filed and possible suspension of Respondent's registration plate.

5. That Quentin Kurt West, by allowing a vehicle to be operated for the purpose of transporting passengers for compensation, in call or demand service, within the Commonwealth of Pennsylvania without receiving certificate/authority from the Commission, has violated 66 Pa C.S. §1101. The penalty for this violation is \$1,000 and possible suspension of the vehicle registration by the Pennsylvania Department of Transportation.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the instant Complaint be SUSTAINED, that the Commission impose a civil penalty upon Quentin Kurt West in the amount of one thousand dollars (\$1,000.00) for the violations described in this Complaint and order such other remedy as the Commission may deem to be appropriate.



NOTICE

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original shall be mailed to:

- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. You may elect not to contest this complaint by paying the fine proposed in this Complaint by certified check or money order. Payment must be made to the **Commonwealth of Pennsylvania** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the complaint proceedings shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
