
COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That 603 TRANSPORT, LLC, Respondent, maintains a mailing address of 1182 Old 115, Dallas, PA 18612.
2. On September 6, 2022, by Commission Secretarial letter, Respondent was issued a certificate of public convenience by this Commission authorizing transportation, as a common carrier, by motor vehicle, property, excluding household goods in use, between points in Pennsylvania at PUC utility code no. 8924663 at A-2023-3042081.
3. On September 8, 2023, PUC Enforcement Officer Barry Pacovsky attempted to contact the carrier by phone and emailed on the same date. Another phone call was placed on October 11, 2023. On October 11, 2023, Officer Pacovsky sent a contact letter to the respondent and a certified letter was sent on October 23, 2023. The carrier accepted the certified mail on October 27, 2023. As of November 11, 2023, no response has been received from the carrier.
4. That Respondent, by failing to achieve a satisfactory evaluation on a safety fitness review, violated 66 Pa §501(c) and, for failure to maintain adequate, efficient, and safe service and facilities, violated 66 Pa. §1501. The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at utility code 8924663.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued to 603 Transport LLC at PUC utility code number 8924663.



- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- D. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
