Dear Mr. Webster,

On October 20, 2023, PECO Energy Company (PECO) filed a tariff filing with the Commission for the approval of the proposed tariff that reflects the elimination of Billing on Supplier Switch (BOSS Billing), changing the use of the customer's account number with a new Electric Choice ID (Choice ID), and removal of the application of late fees to unpaid balances on final bills. In order for us to complete our analysis of your application, the Energy Industry Group requires answers to the attached questions.

Please forward the requested information to the Secretary of the Commission **within 10 days** from the date of this letter. Failure to respond may result in the application being denied. As well, if PECO Energy Company has decided to withdraw its tariff filing, please reply notifying the Commission of such a decision. All documents requiring notary stamps must have original signatures. The Commission strongly encourages submission through efilings with the Secretary of the Commission by opening an efilings account through the Commission's website and accepting eservice at <https://efiling.puc.pa.gov>. The Commission is accepting all public documents through our efilings system at this time.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share Point File system.
