Re: Natural Gas Supplier License of U.S. Gas & Electric, LLC d/b/a Pennsylvania Gas & Electric d/b/a USG&E d/b/a PAG&E

Dear Mr. Moore:

On August 7, 2023, U.S. Gas & Electric, Inc. d/b/a Pennsylvania Gas & Electric (U.S. Gas & Electric, Inc.) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide natural gas services, as a supplier, to U.S. Gas & Electric, LLC d/b/a Pennsylvania Gas & Electric (U.S. Gas & Electric, LLC). In the instant filing, U.S. Gas & Electric, Inc. also filed a request with the Commission to add the fictitious names of USG&E and PAG&E to its current license.

Currently, U.S. Gas & Electric, Inc. is licensed as U.S. Gas & Electric, Inc. d/b/a Pennsylvania Gas & Electric as a supplier to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division¹, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc.², and Valley Energy, within the Commonwealth of Pennsylvania.

U.S. Gas & Electric, LLC has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of U.S. Gas & Electric, Inc. d/b/a Pennsylvania Gas & Electric's name on its license for the provision of natural gas services as a supplier.

The Secretary's Bureau will issue a new license to U.S. Gas & Electric, LLC d/b/a Pennsylvania Gas & Electric d/b/a USG&E d/b/a PAG&E the right to begin to offer, render, furnish, or supply natural gas services as a supplier to residential, small

commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

The Secretary’s Bureau and the Bureau of Administration, Financial and Assessments will update the company’s name in their computer systems and lists, as appropriate, to be U.S. Gas & Electric, LLC d/b/a Pennsylvania Gas & Electric d/b/a USG&E d/b/a PAG&E.
