Dear Mr. Weinert:

The Pennsylvania Public Utility Commission (Commission) previously issued a Secretarial Letter indicating that you met the Commission's minimum qualifications for UVE registration and that you would be registered as a UVE on the Commission's Registry of UVEs. This registration is valid until December 31, 2023. In order to maintain the UVE registration and be listed as a UVE on the Commission's Registry of UVEs for the 2024 calendar year, you must file a renewal application with the Commission by January 1, 2024. UVEs that would like to renew UVE registration must complete the renewal application located on the Commission's website at <https://www.puc.pa.gov/filing-resources/issues-laws-regulations/section-1329-applications/>.
