As originally asserted within Rhonda Jaquay, et al.'s Formal Complaint dated October 13, 2023, within paragraphs 10-12, and 19(G) wherein the undersigned requested, amongst other relief, that the PUC "Grant such other relief as may be necessary or appropriate including ordering the utility and its owner to cease and desist from threatening its customers."

Since the October 13th filing, additional information has come to light regarding communications between the public utility owner and members of the community revealing a pattern of behavior illustrated within the attached communications. One such set of communications attached were with Conneaut resident Ms. Heather Shean, the second of which were with Conneaut resident Tammy Claypoole from a separate but substantively related matter under docket ID 3804411. Finally I am attaching communications with a member of the community who does not wish to be identified for fear of retaliation from the public utility owner but has consented to the message disclosure nonetheless.

These communications are being disclosed at this time in advance of the Public Input Hearings on December 7th for the above-captioned matter so that precautions may be taken to ensure proper candor and testimony without fear of retaliation or threatening conduct from the public utility owner.






