
COMPLAINT

The Pennsylvania Public Utility Commission (“PUC” or “Commission”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That JOSE'S MOVING & HANDYMAN SERVICES, LLC, Respondent, maintains its principal place of business at 1463 Meadowview Drive, Pottstown, PA 19464.
2. That Respondent was issued a certificate of public convenience authorizing transportation of household goods by this Commission on November 15, 2023, Pa. PUC utility certificate no. 8926463, A-2023-3042277.
3. On November 30, 2023, an informal complaint was filed with the Commission alleging violations of the PUC regulations by the Respondent. Documents provided with the complaint indicate Jose’s Moving & Handyman Services would charge a flat rate for household goods move rather than the tariff issued and approved on November 16, 2023.
4. Based on the facts and circumstances detailed in this document, Respondent did hold out to conduct a household good move based on a flat rate and not the tariff approved by the Commission in violation of 52 PA §31.27 (a) 66 CS. §1303.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission hold the Respondent, Jose's Moving & Handyman Services LLC, for the illegal activity described in this Complaint and assessing a fine of two hundred fifty dollars (\$250.00) and order such other remedy as the Commission may deem to be appropriate.



NOTICE

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original **shall be mailed to:**

If your Answer is 250 pages or less, you are not required to file a paper copy. If your Answer exceeds 250 pages, you must file a paper copy with the Secretary's Bureau.

- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. You may elect not to contest this complaint by paying the fine proposed in this Complaint by certified check or money order. Payment must be made to the **Commonwealth of Pennsylvania** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
