Dear Secretary Chiavetta:

Per the Secretarial Letter dated November 28, 2023, UGI Utilities, Inc. – Electric Division (“UGI”) is notifying the Commission that its tax year runs on a fiscal year basis, from October 1 through September 30. Consistent with the letter submitted by UGI on January 6, 2023, at Docket No. M-2022-3037158, UGI will not reflect the CNIT reduction in a January 2024 STAS filing, but will reflect the CNIT rate reduction in its October 2024 STAS filing. Future reductions in the CNIT directed by Act 53 for each year hereafter will be reflected in future STAS filings based on the effective dates for UGI, aligned with the beginning of each fiscal year on October 1.

Consistent with the Secretarial Letter, the Company has executed a verification affirming the accuracy of the information provided in this letter.
