On behalf of all the Parties to this proceeding, Veolia Water Pennsylvania, Inc. ("VWPA") files this status report.

On November 9, 2023, the Parties jointly requested that the Status Conference scheduled for November 21, 2023 be cancelled. VWPA had filed extensive answers to data requests from the Bureau of Technical Utility Services on November 2, 2023, which the other Parties were reviewing.

Since that time, the Office of Consumer Advocate served VWPA with brief discovery, which VWPA answered. The Parties have begun settlement discussions, but desire additional time to continue negotiations.

Due to the holidays, the Parties jointly request that another status report be due in 35 days (January 12, 2024).
